b) <u>Diversity Council Year-in-Review / Introduction of New Members (Diversity Council)</u> Diversity Council Outgoing Chairs Ryan Harrison and Genevieve Gennai spoke with Commissioners about the Diversity Council's accomplishments of the Council during 2022 as reflected in the packet.

Chair Shapiro noted this was an impressive amount of work, both in breadth and scope. Other commissioners thanked the Diversity Council Chiars as well. Ms. Gennai shared a power point introducing the incoming 2023 Diversity Council members. Executive Director Chiang-Smith appreciated the council's hard work, adding that council members perform their council duties along with their regular M-NCPPC work program, and often perform services for the council on their own time, making sure these events and research are successful and productive. She thanked the Council, adding they fill in a critical gap across the agency. Chair Shapiro thanked the council for their leadership and for going above and beyond.

c) <u>Prensentation on Annual Comprehensive Financial Report (ACFR) for Fiscal Year Ending</u> June 30, 2022 (Cohen/Lehman)

Secretary-Treasurer Cohen introduced actuary Chris Lehman, who presented to Commissioners the independent audit results of the ACFR, and Corporate Accounting Manager Abbey Rodman who presented the report itself. Secretary-Trasurer Cohen said the ACFR extends well beyond any traditional reporting requirement to enable enhanced transparency. He added the agency's financial reporting conforms to the highest national standards, something that the agency should be very proud of. He thanked and congratulated his accounting team for putting together this award-winning report.

Mr. Lehman, of SB & Company, independent financial auditors, provided an Executive Summary of the audit. Auditors opine on the agency's regular financial statements and the ACFR itself and issue an unmodified opinion on the Commission's financial statements. Mr. Lehman reported there were no instances of fraud, no material weaknesses in internal controls identified during the audit, said the auditors received the full cooperation of management during the audit, and said no proposed journal entries needed to be proposed.

Director of Corporate Accounting Rodman presented the financial highlights of the M-NCPPC's ACFR. The agency ended the fiscal year in a strong financial position. Contributing factors included strong ongoing property tax base, and increases in revenue, primarily due to the re-opening of facilities and programs due to the loosenting of COVID



restrictions. She reviewed fund balances listed in the ACFR listed by Department and Fund type. The Commission reports healthy fund balances which are in full compliance with the agency's fund balance policy.

- d) Legislative Update. General Counsel Borden said the General Assembly has just started, so the legislators' current focus has been organizing. In the meantime, she said legal staff are ready to brief legislators and discuss bills affecting the agency. As soon as there is an additional update, legal staff will provide one. Chair Shapiro said regular contact with the legislators is critical and appreciated that the team is on top of it. Commissioner Geraldo asked what kind of information are legislators requesting. General Counsel Borden replied that the Montgomery County delegation has been interested in the M-NCPPC's work with the Montgomery County permit department. They have also answered some questions on the collective bargaining bill, what the change is proposed to be, what impact it will have, and how or if it will work differently for each county and the M-NCPC.

#### ITEM 5 MANAGER REPORT/PRESENTATIONS

ITEM 5.A. Wilshire Advisors LLC - Presentation by Bradley Baker, Managing Director and LouAnn Eisenhut,
Assistant Vice President

Mr. Baker provided a Quarterly Executive Summary for the quarter ending September 30, 2022 and reported on the fund's performance. The ERS total fund return was -2.45% (net of fees) for the quarter, outperforming the target policy index return of -4.07%. For the one, three, five, and ten-years ended September 30, 2022, the ERS fund return was -6.05%, 5.31%, 5.70%, and 6.75%, respectively compared to the target policy return of -12.70%, 2.14%, 3.55% and 5.31%, respectively. The total market value through September 30, 2022 was \$1.04 billion. While the total fund return was negative for the one-year ending September 30, 2022, the portfolio held up better than the target policy index and the median public fund return of -14.82%. The ERS had top quartile returns for the one-year ending September 30, 2022 with less risk than other public funds. The ERS continues to be less risky than 95% of public plans.

Mr. Baker discussed rebalancing activity which included submitting a request to liquidate \$25 million from Principal Global Investors. There is currently a queue and the liquidation request may be accepted in 1Q2023.

Mr. Baker discussed the Quarterly Manager Watchlist, including specifically Neuberger Berman's underperformance compared to the benchmark. According to the watchlist, Neuberger Berman is also underperforming against its peer universe. Ms. Eisenhut added that Neuberger Berman has a Grade B, however it is struggling with portfolio manager turnover. In accordance with the Investment Manager Monitoring Policy, Section B.1., the Board decides if a manager is placed on Watch. Mr. Baker recommended the Board place Neuberger Berman on the Watch status due to underperformance. Ms. Rose informed the Board that Neuberger Berman is scheduled for a performance review with the IMG in June of 2023. Mr. Baker agreed to notify Neuberger Berman about being placed on watch status.

ACTION: MR. COHEN made a motion, seconded by MS. CHIANG-SMITH to approve Wilshire Advisor's recommendation to place Neuberger Berman on Watch status effective December 6, 2022 due to

underperformance. The motion PASSED (9-0) (Motion # 22-57).

Letter and proceed with the investment in the Nuveen Senior Loan Fund, LP. The motion PASSED

#### ITEM 8 ADMINISTRATOR'S REPORT

Ms. Rose presented the Administrator's Report dated November 21, 2022. Ms. Rose informed the Board on the Commission's decision to support Resolution 22-38 which extended the annual leave carryover above the maximum through the end of calendar year 2023. The ERS typically follows the Commission with respect to usage, accumulation, and carryover of leave. Ms. Rose explained the extension would recognize the diligent efforts of staff in response to the COVID-19 pandemic and increased work program requirements and recommends the ERS follow suit with the Commission's decision extend carryover of annual leave through December 31, 2023.

ACTION:

MS. CHIANG-SMITH made a motion, seconded by VICE CHAIRMAN PRESLEY to authorize a temporary modification to the ERS Employee Handbook, Section VII. Employee Benefits, by allowing employees, including the Administrator, an extension to carryover annual leave above the maximum from December 31, 2022 until December 31, 2023. The motion PASSED (10-0) (Motion # 22-63).







The Maryland-National Capital Park and Planning Commission ("Commission") seeks to upgrade existing portions and to design and construct new portions of the Capital Trails Network being developed and managed by the Commission for active transportation and recreation (bicycling and walking). The Commission and its partners plan to submit a grant application to the United States Department of Transportation ("USDOT") *Rebuilding American Infrastructure with Sustainability and Equity* ("RAISE") grants pursuant to the Consolidated Appropriations Act, 2023.

The application requests an amount up to \$25 million to address an urgent and critical need to rehabilitate existing and construct new multi-use paths to fill key gaps in the bicycle and pedestrian trail network in the Washington, DC metropolitan region. This project will directly improve outcomes for traditionally underserved populations and promote multimodal transportation.

The federal share of project costs may not exceed 80 percent, so the partners collectively must contribute at least 20% of the project cost from non-federal sources. The Commission and its partners intend to contribute more than the required 20% (\$7,400,000), to make the application more competitive. Staff requests that the Commission approve matching funds up to \$16,225,000.

The proposed projects include six (6) capital projects: Arboretum Bridge and Kenilworth South Trail (in Washington, DC); Central Avenue Connector (in Prince George's County); Prince George's Connector / Anacostia Gateway (in Prince George's County); Suitland Parkway Trail (in Prince George's County); Sligo Creek Trail Rehabilitation (in Prince George's and Montgomery Counties); and Northwest Branch Trail Rehabilitation (in Montgomery County).

This is the third year in which the Commission and its partners have collaborated on a RAISE grant application. This year, Prince George's County Office of the County Executive will submit the application to leverage the County's support and advocacy for the partners' submission.

WHEREAS, the Commission and its partners wish to complete critical gaps and fill in missing connections in the Capital Trails Network with six (6) capital projects: Arboretum Bridge and Kenilworth South Trail (in Washington, DC); Central Avenue Connector (in Prince George's County); Prince George's Connector / Anacostia Gateway (in Prince George's County); Suitland Parkway Trail (in Prince George's County); Sligo Creek Trail Rehabilitation (in Prince George's and Montgomery Counties); and Northwest Branch Trail Rehabilitation (in Montgomery County) (collectively, "Projects"); and

WHEREAS, the United States Department of Transportation ("USDOT") is now soliciting applications for Rebuilding American Infrastructure with Sustainability and Equity ("RAISE") grants pursuant to the Consolidated Appropriations Act, 2023; and

**WHEREAS**, USDOT will award RAISE grants on a competitive basis for capital surface transportation infrastructure projects that will have a significant local or regional impact; and

WHEREAS, the Commission wishes to empower staff of Prince George's County Department of Parks and Recreation and Montgomery Parks to work together on an application for a RAISE grant to be submitted by Prince George's County / Office of the County Executive in an amount up to \$25 million in order to assist the Commission in funding the Projects that would otherwise be funded by Commission capital improvement funds or other funds over which the Commission has oversight; and

WHEREAS, according to the RAISE grant Notice of Funding Opportunity, the federal share of project costs may not exceed 80 percent, so the partners collectively must contribute at least 20% of the project cost from non-federal sources including State funds originating from programs funded by State revenue, local funds originating from State or local revenue-funded programs, or private funds. The Commission and its partners intend to contribute in excess of the required 20%, to make the application more competitive.

**NOW, THEREFORE BE IT RESOLVED** that Commission staff may work together on an application to be submitted by Prince George's County / Office of the County Executive for a RAISE grant (including all understandings and assurances contained in such application) from United States Department of Transportation in order to assist the Commission in funding the Projects; and

**FURTHER RESOLVED**, that the Commission approves matching funds in the amount of at least \$7,400,000 but up to \$16,225,000; and



## Overview

- The July 1, 2022 actuarial valuation was performed to determine the FYE 2024 recommended contribution.
- Includes impact of 2022 Election Rate Experience Study assumption changes
- **ADC** *increased* from \$35,913,000 to \$37,943,000
- Net Trust Contribution <u>decreased</u> from \$9,409,000 to \$8,556,000
- FYE 2022 GASB Disclosure is based on the prior July 1, 2021 OPEB valuation report
- FYE 2023 GASB Disclosure will reflect the July 1, 2022 valuation report



# Overview of Valuation Assumption Changes

- Annual updates to the claims assumption (which includes actual plan experience) and to the discount rate/expected rate of return assumption.
  - Recent claims experience resulted in only a small increase in contribution and total OPEB liability.
- Updated election rate assumptions based on the 2022 experience study

# **Assumption Changes**

(Annual Updates)

- Per Capita Claims Cost Assumption
  - Claims experience from 7/1/2019 6/30/2022
    - Blended three years of experience this year (two years last valuation)
    - Pre- and Post-Medicare Medical and Rx Claims increased slightly more than expected during FYE 2022, resulting in a small loss due to claims experience
  - Pre-Medicare Premiums decreased slightly for Kaiser Permanente HMO Plans and remained the same for UHC Select EPO and Choice Plus POS Plans.
  - Medicare Premiums remained the same since the prior valuation as well.
- Discount Rate/Expected Rate of Return
  - Reduced from 6.75% to 6.70%
  - Budget Forecast assumes continued reduction in discount rate and investment rate of return by 0.05% annually to 6.50% in 2028





# **Assumption Changes**

(Election Rate Experience Study dated September 30, 2022)

- Prior Assumptions
  - 100% of active employees will elect coverage at retirement
  - 70% of active employees who elect coverage will elect spousal coverage
- Updated Assumptions
  - •97.5% of active employees will elect coverage at retirement



Model inputs will be updated periodically based on the best estimate of the economy at that time. Small changes in the model inputs can results in actuarial losses or gains of 5 to 15 percent of liabilities.
